- **Entry fee** is \$30 for one piece, \$50 for two pieces, maximum two pieces
- **Submit digital entries** on CD or by email, (medium resolution please, CDs will not be returned) charlestonartist@bellsouth.net

- **Size limit: Maximum 38" width** including frame, minimum 8" X 10", 10 or 13 larger pieces accepted on a first come basis as wall space is available
